

Regulation POOL " ball 8 " RULES OF GLOBAL STANDARD

For the general rules of pocket biliard shall apply with the exception of cases in which are clearly contradicted by these additional rules .

1 - OBJECT OF THE GAME

"ball 8" is a game shootings declared . You use a cue ball and 15 balls numbered from 1 to 15. A player must post the balls of the group numbered from 1 to 7 (Full) ,while the other has the group of balls from 9 to 15 (a strips) . The player that pits before his group and then the bilia Number 8 in a manner to regulate wins the game .

2 - CALL SHOT (SHOT DECLARED)

in shooting declared the balls for obvious and holes must not be indicated . It is in the law of the opponent require the indication of the ball and the hole where it is not sure of the shot that you are doing . Shootings of shore or carom are not considered obvious and must indicate both the numbered bilia that the pit considered . When the shot is declared is never necessary to indicate the details such as the number of banks , pinning , carambola , etc . The balls posted by committing foul remain in the pit, independently from the fact that they are of the Group of the shooter or than his opponent . The shooting of opening split () is not considered a shot declared . The player who opened the game has the right to continue to pull only if during the split imbucato has so regolamentere one or more balls numbered .

3 - Positioning of the balls triangle ()

For the shooting of opening split () The balls must be collected in a triangle at the bottom of the table . The first ball must be positioned on the median point of the bottom line , the bilia number 8 at the center of the triangle , a bilia full in a corner and a ball into strips in another .

4 - alternating opening

the winner of a game has the possibility to open the game in the next game . During the official competitions players alternate in the opening in each subsequent batch .

5 - foul caused by blows of JUMP AND MASSES'

while the fouls caused by the cue ball alone are considered when a consignment is not directed by an arbitrator , the player must know that it will be considered a foul if , during the attempt to skip , bend or do massè with the cue ball around or above a ball numbered obstacle , this will be moved (irrespective of the fact that this occurs due to blows of hand , blows accompanied , etc ...) .

6 - Shooting OF OPENING valid

definition () to perform a shot of valid opening the shooter , with the cue ball inside the area delimited by the head line (first quarter table) , must post a ball or let it touch the tailgate with at least four balls .

If it fails in performing an opening to regulate , is considered foul and the other player has the possibility to accept the arrangement of the balls and pull or to recompose the triangle and choose whether to reopen the game or make it reopen to the opponent .

7 - white ball in the hole DURING A VALID OPEN

if a player sends the white ball in the hole during the shooting of opening all the balls posted remain in the pit with the exception of the ball 8 (see Rule 9) while it is foul if the game remains open (see Rule 10) .

Note: The ingoing player has the cue ball in hand and can pull from behind the head line , but cannot pull the balls that are located behind this , unless it strikes regularly a ball that is located above the head line and then go back with the wing and hit the ball otherwise not playable .

8 - A BILIA skipped from the table during the opening

if a player makes skip a ball out from the table during the opening it is foul and the ingoing player has the possibility to accept the arrangement of the balls and pull or pull with ball in hand behind the head line .

9 - Ball 8 posted during the opening

if the ball 8 is sent into the hole during the opening one who has pulled may ask to recompose the triangle or put the ball 8 and continue to pull . If the player that opens the Game Fouls while sending in the pit the bilia number 8 , the ingoing player has the possibility to reopen or reposition the ball 8 and begin to pull with the ball in hand behind the head line.

10 - Open Game

The game is open when the choice of groups (striped and full) has not yet been done . When the game is open is to regulate strike before a ball full to post a swath or vice versa .

Note : The game is always open immediately after the opening .

When the table is open , you can hit any bilia including the number 8 to post the bilia declared . However , when the game is open and the ball number 8 is the first to be touched no bilia (full or streaked) , if posted can be assigned to the shooter that loses the shot ; every bilia posted so remains and the opponent continues with the game still open . With the game open , all the balls posted a regulation remain in the hole .

11 - CHOICE OF GROUP

The choice concerning solid balls or streaking is not determined after the opening , even if the balls of one or of both series are posted . The game is always open immediately after the opening , the choice of the group is determined only when a player sends in pit a numbered bilia declaring it after the opening .

12 - regulatory shooting

(definition) during all the shootings (except the opening and when the game is open), the player must strike a ball of his group and imbucarla.

N.B. It is allowed the shooter touch one or more panels before the bilia numbered, however ,after being touched, a numbered Bilia should be posted or the leaf or any other bilia ,must touch at least one wall. Lacking this condition, the shot will be considered irregular.

13 - "SAFETY" shot defense ()

For tactical reasons a player may choose to post a numbered bilia obvious and stop his turn at the table stating "SAFETY" (defense) in advance .

A shot of defense is considered valid only if the player who wants to play defense, by sending in the pit a bilia obvious , before pulling , declares to his opponent the intention to carry out a shot of defense . If this is not the case , and one of the balls of the shooter is posted , they will be told to continue the series . Any bilia posted during a shot of defense remains in the hole .

14 - SEQUENCE OF GAME

A player can continue to pull until the wrong in the post regularly a ball of his group . After a player has regularly imbucato all the balls of his group , pulls to send in the pit the bilia number 8 .

15 - PENALTIES FOR fouls

the opposing player gets the ball in hand . This means that the can be positioned in any point of the table (must be behind the head line only in case of Fouls committed during the opening) . This rule prevents the player to commit intentional fouls that could penalise his opponent . With the "ball in hand" the player can use the hand or any part of the carton (including the tip) to position the leaf . After it has been positioned , any shot that causes a forward movement of the ball will be considered foul unless a regulatory shot .

16 - SHOOTINGS OF CAROM

are allowed shootings of carom ; however the bilia number 8 cannot be used as a first ball in the carom except when the game is still open (see Rule 10) .

17 - BALLS POSTED IN SUCH A WAY NOT TO REGULATE

shall be deemed to be posted in such a way not to regulate a numbered ball when it is posted in the same shot in which is committed a foul , or when the bilia declared entry is not in the pit designated ,or when a defense is declared before the stroke .

The balls posted in such a way not to regulate remain in the hole .

18 - The numbered balls jump out from the table

if a numbered bilia jumps off the table is foul and the game goes to the opponent with the cue ball in hand , unless it is of the ball number 8 that would lead to the loss of the game . Any numbered ball that jumps out from the table is arranged in numerical order according to the general rules on the disposal of the balls .

19 - HOW TO PLAY THE BALL 8

when playing the ball number 8 and a foul was committed , the game is not lost if the ball 8 has not been posted or is not skipped out from the table . The ingoing player can pull with the "ball in hand" .

20 - LOSS OF A GAME

A player loses the game by committing any of the following :

a - foul when pits the bilia 8 (excluding shooting opening ,art 4 and 9) b - pits the bilia 8 together with the last ball of his group

c - ago skip the ball 8 out from the table at any time of the lot

d - pits the ball 8 in a pit different from that declared

and - pits the bilia 8 before having finished its series .

Note: All infringements must be notified to the player before that has carried out the next throw , otherwise it considers that it has not been no infringement.

21 - PARTITA IN DEADLOCK

if after 3 consecutive shifts of the game by each player (6 rounds in total) , no player seems to be willing to close the game , not to run the risk of losing it , is the faculty of the arbitrator to repeat the game because stalled, and grant the shot of opening to the player who has opened the match suspended .

N.B. : Three consecutive fouls do not result in the loss of the game .
